PRE-NEED FUNERAL ARRANGEMENT

HAVING A PRE-NEED FUNERAL ARRANGEMENT CAN BE ESTABLISHED AS A METHOD OF GUARANTEEING ALL YOUR FINAL CONCERNS ARE CONTROLLED BY YOU. IT ENSURES THE LOCKED IN AMOUNT ON THE PRE-NEED ARRANGEMENT CONTRACT FOR FUNERAL AND/OR CREMATION SERVICE BY THE FUNERAL PROVIDER IT WILL NOT INCREASE. WE DO NOT REQUIRE A MEDICAL EXAM, IT MAY BE PAID FOR OVER TIME. THE DOWNPAYMENT IS 10% OF THE FINAL COST ON THE PRE-NEED ARRANGEMENT CONTRACT. WHEN THE FINAL DISPOSITION IS BURIAL, THERE WILL BE A CEMETERY CHARGE ON THE STATEMENT OF GOODS AND SERVICES, DUE TO THIS BEING A CASH ADVANCE ITEM. SOME CEMETERIES CHARGE FOR OPENING AND CLOSING OF A GRAVE, SO WE MAY PURCHASE THE GRAVE IN ADVANCE, TO LOCK IN THE PRICE OF THE GRAVE. HOWEVER, THE PRICE FOR OPENING AND CLOSING OF A GRAVE IS DETERMINED BY THE CEMETERY PROVIDER, WHICH GOES UP EVERY YEAR. A PRE-NEED ARRANGEMENT CONTRACT COULD BE VIEWED AS A SELF BURIAL/LIFE ASSURANCE SAFEGUARD FOR A PERSON WHO MAY NOT BE ABLE TO OBTAIN BURIAL INSURANCE OR LIFE INSURANCE.

PAYMENT OPTIONS

ONCE A PAYMENT OPTION HAS BEEN ESTABLISHED, THEY ARE FOR A PERIOD OF 18 MONTHS. THE DOWNPAYMENT WILL BE \$1,500 ON ALL FUNERAL AND CREMATION CONTRACTS. THE FIRST PAYMENT WILL BE DO IMMEDIATELY, ALL OTHER PAYMENTS DO WITHIN 30 DAYS OF THE INITIAL SIGNING OF THE CONTRACT. THE FIRST PAYMENT MUST BE PAID ONLINE, IF MONEY IS BEING DONATED, PLEASE MAKE SURE IT PAID ON THE ACCOUNT THAT PURCHASER HAS SET UP FOR PAYMENTS. DO NOT USE OUR DONATION PAGE TO MAKE PAYMENTS ON CONTRACTED AGREEMENTS. PAYMENTS MADE DURING THE 18 MONTH PERIOD CAN BE PAID BY CASHIERS CHECK, DEBIT, CREDIT, OR DEDUCTED OUT OF AN ACCOUNT.

TITLE 19 FUNDS USED BE USED AS A DOWN PAYMENT ONLY IF APPROVED. A PURCHASER WILL HAVE TO GET CLEARANCE FROM THEIR BANKRUPTCY ATTORNEY IF THEY SELECT A PAYMENT OPTION, AS WE WILL HOLD THE CONTRACT FOR GOODS AND SERVICES AS LEGAL OBLIGATION OF THE PURCHASER. THE TITLE 19 APPLICATION FOR FUNERAL AND BURIAL REQUEST MUST BE SIGNED IN PERSON.

ALL FUNDS COLLECTED AT A FUNERAL OR MEMORIAL SERVICE WILL APPLIED TO THE CONTRACT REDUCING OR SATISFYING THE FINANCIAL OBLIGATION OF THE CONTRACT. THE PURCHASER MUST ENSURE TO STATE THEY WILL BE USING INPERSON SOLICITATION OF FUNDS IN THE PAYMENT OPTION. THY KINGDOM COME FUNERAL SERVICES IS NOT RESPONSIBLE TO SOLICIT ANY IN-PERSON FUNDS AT A FUNERAL OR MEMORIAL SERVICE.

THE GENERAL PRICE LIST WITH EACH ITEM SELECTED WILL BE INDIVIDUALLY PRICED TO ENSURE THE PURCHASER HAS A CLEAR UNDERSTANDING OF WHAT THEY REQUESTING SERVICE FOR.
